NOTES:-

1. Membership season runs from 1st March to the end of February each year.
2. Introductory membership is for people who have never been a member of Hilton Park or former members who have been away from the club for a minimum of two years.

Level 1 members can only play on the Allander course during the week and after midday at weekends. Level 1 members may play on the Hilton Course on payment of 50% of the normal adult green fee per game. Level 1 members are expected to graduate to Level 2 membership after their first year at Hilton Park Golf Club.

Level 2 members can only tee off, on both the Hilton and Allander courses, before 4pm weekdays and after midday at weekends. Level 2 members are expected to move to Ordinary membership after they have been a Level 2 member for one year. There is an option to stay at Level 2 for a further year if requested.

3. Family Membership - £1,287 covers the subscription for two adults (Ordinary Membership playing rights, with only one member having voting rights) and any of their children under 18 years of age.
4. Age restrictions relate to age as at **1st March**. For example any girl/boy who attains the age of 10 years after the 1st March 2016 will still maintain Cadet Membership for 2016.
5. VAT is charged at 20%. VAT No: 260 2690 75
6. Fees are due in advance of the membership year. There is the option to pay by direct debit over 9 months with no charge for the facility. Subscriptions only may be paid by 2 equal instalments on 1st of March and 1st June (the bar subscription, locker rent and insurance needs to be paid on 1st March). 7. No Proposer and Secunder are currently required.
